



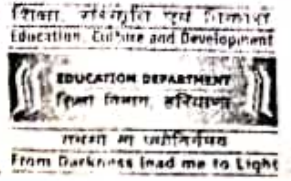
### SCHOOL MANAGEMENT COMMITTEE
